2] AND WHEREAS, in accordance with Chapter 3 of the said Rules of the University, Internal Committee at Off Campus Centre of Symbiosis International (Deemed University) at NOIDA was constituted vide Notification No. SIU/ U-28/ 832 dated 24th June, 2019;

3] AND WHEREAS, the tenure the Internal Committee at Off Campus Centre of Symbiosis International (Deemed University) at NOIDA constituted vide Notification No. SIU/ U-28/ 832 dated 24th June, 2019 and reconstituted from time to time has come to an end on 23rd June 2022;
