Viva voce examination will be conducted by a panel consisting of internal and external members (appointed by the Symbiosis International (Deemed University)).

<sup>2</sup>The course will be conducted by senior legal practitioners through simulation and case studies. Evaluation will be conducted in practical exercises for 120 marks and viva voce for 30 marks. Evaluation will include written test (80 marks), case study (20 marks), Periodical problem solution (20 marks) and viva-voce (30 marks). Vive voce examination will be conducted by a panel consisting of internal and external members (appointed by the Symbiosis International (Deemed University)).

4This course will have three components: a. Moot Court (Three moot courts with 10 marks each= 30 marks); b. Observance of Trial in two cases, one Civil and one Criminal (30 marks); and c. Interviewing techniques and Pre-trial preparations and as per the given format, cumulative Internship diary (60 marks). Each student will further observe the preparation of documents and court papers by the Advocate and the procedure for the filing of the suit/petition. This will be recorded in a separate diary. In addition to the above three components, the fourth component will be Viva Voce examination on all the above three aspects (30 marks). Vive voce examination will be conducted by a panel consisting of internal and external members (appointed by the Symbiosis International (Deemed University)).
